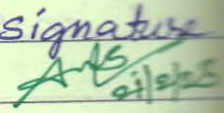
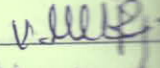
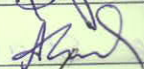
1. The Chairperson welcomed the members of the women cell and briefly reviewed the status of grievances and found that there are no recorded grievances.
